• Point Resort Lease Modification

The current lease agreement provides that the Town of Dandridge receive a percentage of alcohol sales from the Lessee's sale of alcohol. The Attorney General for the State of TN has opined that the aforementioned lease provision is illegal. The Town and lessees agree that the provisions in the lease providing that the Town receive a percentage of alcohol sales from the Point are stricken, with all other provisions to remain in full force and effect.

• Request for Additional Funding for East Dumplin Valley Road Widening Project
