• Ordinance Amending the "Zoning Map of the Town of Dandridge, TN" a Component of the "Zoning Ordinance of the Town of Dandridge, TN" from an A-1 (Agriculture District) to a R-1 (Low Density Residential District) (Hart Road, Map 58, Parcels 20.01 & 31)

It came on a motion by Mayor GANTTE, seconded by Commissioner FRANKLIN, to approve the rezone and recommend to BMA for passage.

On a voice vote, the motion passed unanimously, and was so ordered.

• Ordinance Amending the "Zoning Ordinance of the Town of Dandridge, TN" by Revising Section 14-408(1) to Include Sale of Manufactured Homes as a Permitted Use in the B-2 General Business District

Amend the above Ordinance as follows to add: All permanent commercial structures (such as office buildings) using a pier foundation type shall cover the exposed crawl space with a masonry concrete block perimeter that is within 2" of the subfloor of the structure. The exterior finish of the block shall either be painted or have a brick/stone/stucco façade. Display structures/models shall cover the exposed crawl space with a temporary skirting.

It came on a motion by Commissioner OPEIL, seconded by Commissioner FRANKLIN, approve the Ordinance as amended and recommend to BMA for passage.

On a voice vote, the motion passed unanimously, and was so ordered.
