# TOWN OF DANDRIDGE, TENNESSEE BOARD OF MAYOR AND ALDERMEN Regular Meeting 10 October 2023

#### I. CALL TO ORDER

#### III. PUBLIC HEARING

• Off Premise Beer Permit Application, Harry Spencer (Corporate Officer), Family Dollar Stores of TN (#26639), 1042 South Hwy 92, Dandridge

Rob Hosack, Decisions Consulting, representing Family Dollar LLC, have a number of internal store operations to be cognitive to not selling underage such as video surveillance (both outside and inside), utilize handheld scanner technology to help with ID recognition, all associates participate in an initial training program to include periodic updates, employs an outside vendor to assist with training, has a zero tolerance policy with immediate termination, and then all store personnel has to go through another particular training program. National violations with Family Dollar are less than 1.5% with 3,500+ stores. Family Dollar does take the sale of beer seriously.

Alderman DEPEW advised Mr. Hosack of the Responsible Vendor program and how it affects participants if underage sales are made.

• Re-Bid – 2020 CDBG I&I Sewer System Improvements Sewer Line Extension

12" sanitary sewer line and manholes (from behind Jeff Co Workhouse to Nichols Road) – Merkel Bros. Construction, Inc. - \$1,165,170.00

Funding avenues = ARPA funds & CDBG funds (ARPA funds = \$1,124,800 minus the county match of 25% of their funds (\$895,000), with approximately \$1.2 million remaining in ARPA funds).

It came on a motion by Alderman REESE, seconded by Alderman CHAMBERS, to approve the bid from Merkel Bros Construction.

• Dandridge School Lofts – 10' Sanitary Sewer & Temporary Construction Easements

Sewer line will come down across front edge of the city lot along Banner Street and tie in down around the TVA property on Gay Street.

It came on a motion by Alderman CHAMBERS, seconded by Alderman NELSON, to approve the easements.

It came on a motion by Alderman DEPEW to amend the previous motion by asking for \$10,000 for the easements. Amended Motion failed for lack of a second.

 Grant Contract between the State of TN Dept of Tourist Development & Town of Dandridge - \$100,000 Grant / \$30,000 Grantee (Addition of Outdoor Pickle Ball Courts and Updates to Baseball/Softball Field Backstops)

80/20 grant, pickle ball courts and restroom on recently purchased property at Field of Dreams. Future project would include a playground facility and pavilion.

\$400,000 from tourism funds.

It came on a motion by Alderman NELSON, seconded by Alderman REESE, to approve the grant contract.

• DVFD Station 2 – Garland McCoig Fire Station Resolution

Resolution No. 10/11-17 (May 17, 2011) named the Town's Fire Station No. 1 the "Garland P. McCoig Fire Station".

A ceremony was held on September 28, 2023 naming the Town's Fire Station No. 2 the "Garland McCoig Fire Station".

It was the consensus of BMA to update the original resolution to name Fire Station No. 2 as the "Garland McCoig Fire Station".

• Dandridge Fire Department Public Protection Classification: (ISO) 04/4X

Informational purposes. It was the consensus of BMA to include this item once again on the next agenda.

• Dandridge Ministerial Association Christmas Tree Lighting Ceremony – November 30, 2023 at 6:00 p.m.

Addressed above in "PUBLIC PRESENTATIONS/COMMENTS" with Bobbie Fraska.

• Merriment on Main

\$2,500 is budgeted for Christmas in Dandridge (expect to spend approximately \$1,000 on a tree + \$500 for lights, etc). Remaining \$1,000 can be used for Merriment on Main.

Kristin Depew – requested \$1,200 from the Christmas in Dandridge budget in addition to the following:

- Christmas in Dandridge November 25<sup>th</sup>, every Saturday thru December 23<sup>rd</sup>.
  - November 25<sup>th</sup> Merriment on Main St. (small business Saturday), Llamas, facepainting, balloon twisters, magic, Knead Doughnuts, town Christmas tree ornaments, free Christmas pictures, vendors, shopping (Asking the town to sponsor/purchase the cost of Llamas (\$473) and face painting/balloon twisting (\$500) Tourism and Jefferson Alliance may purchase the ornaments and other children activities (cookie decorating, etc).
  - December 2<sup>nd</sup> Reindeer Run/Walk, partnering with the Chamber of Commerce, adult/student leadership classes and other groups to participate, proceeds will go towards Shop with a Cop. Also a Jingle Paws parade with dogs and pictures. Alderman Chambers will be Santa.
  - December 9<sup>th</sup> cookie crawl, candlelight shopping, and carriage rides
  - $\circ$  December 16<sup>th</sup> candlelight shopping, carriage rides
  - December 23<sup>rd</sup> DVFD Christmas Parade

Request the town to sponsor/pay for Llamas, facepainting and reindeer antlers for the reindeer run for a total of \$1,143.

Still need funds for carriage rides and advertising.

*Jefferson County Post will donate advertising and partner with Facebook boosting in partner with the town. Request \$1,800 in addition to the \$1,000 left in the Christmas in Dandridge budget line item for advertising and carriage rides for two nights.* 

Invoices will funnel through the town to be paid.

Suggested to institute the sale of Christmas in Dandridge shirts once again with proceeds going into the Christmas in Dandridge line item for future use.

It came on a motion by Alderman CHAMBERS, seconded by Alderman REESE, to pull \$1,800 from the contingency fund for Christmas in Dandridge.
