TOWN OF DANDRIDGE, TENNESSEE BOARD OF MAYOR AND ALDERMEN Regular Meeting 9 April 2024

I. CALL TO ORDER

- **A.** The Dandridge Board of Mayor and Aldermen (BMA) met in a regular session in Dandridge, Tennessee on Tuesday, the 9th day of April 2024.

III. PUBLIC HEARING

• Second Reading of **Ordinance No. 23/24-22** Establishing Regulations for "Short Term Rentals" within the Corporate Limits of the Town of Dandridge, TN.

Town Attorney Jeff Greene – After last month's meeting, there were several calls with regards to Section 14-702: Eligibility to Obtain a Permit. Only those property owners in R-1, R-2, R-3, B-1, B-2, and B-4 are eligible to use their properties for short-term rentals. Everything else was taken out, there are no qualifiers. If your property is in one of those zones, you are qualified if it's a legal use.

Janet (836 Lakeshore Drive) – Using VA eligibility to purchase a home in Dandridge to specifically use for short-term rental. Chapter 972 of the Tennessee Code (Section 66-38-104) A local government should not prohibit using a property as a short-term rental or regulate a short-term rental based on the rental's use, classification, or occupancy. Additionally, the TN act contains a legacy grandfather clause which states short-term rentals already established prior to the enactment of local ordinance are regulated under the laws when the short-term rental was established and are not affected by a new ordinance. There has been no clear evidence that renters need any more protection than what is already required by short-term rental platforms. A short-term rental may not be regulated any differently than all other residences.

Jason Martin – Should embrace history of providing hospitality to travelers. Short-term rentals play a vital role in providing travelers with a unique opportunity to understand the history and culture of Dandridge.

Kesley Tucker – Every single page of the ordinance has problems. November of 2023 court ruling stated that Airbnb's are not commercial and not hotels. Can't be regulated as either. They are residential and are to be governed as residential. Board recently passed an ordinance to allow gun sales in homes and deemed that as safe, but have a problem with people coming and using homes in the same manner the homeowner would be using property. Not opposed to a permitting process or inspections. Who is going to be in charge of the permitting process? Who is going to fund it? Where is the clear and convincing evidence that the public's health and safety is in jeopardy.

Town Attorney Jeff Greene – Public Chapter 972 is an advisory paper that was written before the law was passed, it is not the law. TCA 13-7-601 is the short-term rental act. What we have written is legal. We should listen to people's concerns.

Stacey Martin – Doesn't have a short-term rental, speaking on business and welfare of community. Comparing us to Pigeon Forge is apples and oranges with this ordinance. Long-term rentals should be treated the same way we are looking at short-term rentals. The Point is full of short-term rentals. Airbnb's fuel my business. The tourists put money into this city. Clause in ordinance says owners have to be within 45 minutes of property 24/7. Why can't police respond?

Emily Miller - we need tourism for local economy without giving up local charm. Let's be fair to the rental homeowners. We cannot stop progress from moving into Dandridge. Worked in major tourism areas such as San Diego, Dallas and Las Vegas...currently work at Mountainview. Offering assistance as an operating agent who can respond within 45 minutes to an occurrence on the property. Will physically check property and can hit every properties within 48 hours.

Sonja Hill – not here to talk about the ordinance. Quick analysis of property and sales tax of short-term rentals and workers equates to loss of \$229,000 for the city if short-term rentals go away. What will happen to all the wedding venues we have is people can't find somewhere to stay for the wedding? Snowball effect will take hold financially.

Aurora Pulliam – doesn't think anyone truly wants to get rid of short-term rentals. Not opposed to tourism, small business...but I'm concerned because everything in my neighborhood is being promoted as an Airbnb. One of the biggest problems is trash collection and should be addressed in the ordinance. Doesn't believe \$300 fee isn't enough to manage the program correctly. Copy and pasting another city's ordinance is not the right approach because they aren't Dandridge.

Mayor Gantte – would like Attorney Greene to go back through the ordinance thoroughly and make sure we meet all state law criteria before something is passed.

Alderman Elder/Depew - Max Occupancy should be looked at. 2 people/bed is good guidance. Take out maximum limit.

Alderman Nelson – If we take out maximum limit and it's a big house, where is the parking going to be? This is why we need somebody close to handle problems that arise. **Alderman Reese** – 45 minutes is adequate time frame. **Alderman Nelson** – this was not mean to shut down short-term rentals, we just want short-term rentals to be safe.

Attorney Greene – State has codes in place already for both long-term rentals and rv parks. Sewer is not addressed in this ordinance. Some of this the homeowners have to regulate themselves.
