IX. PRESENTATION OF ORDINANCES AND RESOLUTIONS

Resolution No. 23/24-21 A Resolution Adopting Revisions to the Urban Growth Boundary

Town Administrator Shockley – had 2^{nd} public hearing tonight. This is to officially request the reconvene of the urban growth boundary committee and get the ball rolling.

• **Resolution No. 23/24-22** A Resolution Endorsing the Use of Visual Surveillance Devices to Enhance Law Enforcement in the Town of Dandridge

Town Administrator Shockley – a request from Flock to get board support. Flock is a specific brand of license plate readers. They do compile data used specifically for law enforcement. Information is stored for 90 days on their in-house servers. Information is shared between law enforcement departments that are subscribers of Flock. Initial site is EB off ramp and WB off ramp and potentially near Bucks and Bass coming into town. Could possibly use a private business to have a Flock presence covering 25/70 and 92.

Alderman Nelson – Where will the cameras be installed? Initial site is EB off ramp and WB off ramp and potentially near Bucks and Bass coming into town. Could possibly use a private business to have a Flock presence covering 25/70 and 92.

Alderman Elder – Are there any other cities using these? Jefferson City and White Pine are participating in the county. Sevierville, Newport, Knoxville.

Alderman Depew – <u>huge liability on personal information</u>. If there is a breach, who is at fault? Is it flock or the town? The information belongs to Flock so they will be solely responsible.

Alderman Chambers – what is lifespan? 4/6 years per camera

Vice Mayor Kesterson – what is the financial commitment from the town? \$14,600 for camera purchase. That is an annual subscription. \$3,600 per individual unit and \$7,500 for intersection unit. Year to year contract.

Police Chief Williams – These cameras are not speed enforcement. Flock doesn't share personal information with us, just video. It is totally cloud based and they are responsible for information. A good tool used for crime fighting.

Town Administrator Shockley - Highlights

<u>Central Staff</u> – Bonuses, AED's – grant from Jefferson County Health Fund (\$25,088), ARPA Funds for holiday decorations

<u>Police</u> – Bonuses, extra firearm supplies, police vehicles and upfitting (\$264,300), grants for tasers <u>Fire Department</u> – ARPA Funds transfer for new fire truck (\$425,000), bonuses, new sign for station 2 <u>Highways and Streets</u> – Storm clean-up (\$30,500), Combo tractor/truck purchase (\$151,752) State Street Aid – Paving

Sanitation – Transfer for Garbage Truck purchased in prior year (\$314,789.14)

Recreation – Field Lights (\$105,200)

• **Second and Final** Reading of **Ordinance 24/25-01** Adopting the Annual Budget for the Fiscal Year Beginning July 1, 2024 and Ending June 30, 2025.

Town Administrator Shockley - Highlights

- Budget is balanced but comes with conservative estimates due to the uncertainty of the property tax revenue.
- o Includes 5% raise or pay-scale revision for employees, whichever is the larger of the two (\$236,000 increase over last year including TCRS bump)
- o TCRS rate bumped up to 15% from 12%
- $\circ \quad \textit{Includes 5\% health insurance premium increases, 3\% dental insurance premium increase.} \\$
- o Dandridge Water Department \$439,158 profit anticipated. No price increase.

XI. NEW BUSINESS

• Industrial Development Board Presentation (Steve Hammer)

Steve Hammer (Chairman of Jefferson County Industrial Board) – Discussing possibility of sewer expansion to 412/415. Trying to get ahead of the development that is happening at 407/408. If we could sewer, it would be easier to market those areas. Looking to bring in engineer (Matt Hatfield) to do a master plan. Master plan would allow us to pursue grants with the state. Will be approaching Jefferson Alliance and the Jefferson County Commission on the project.

Alderman Elder – who is paying for the master plan? Tentative estimate is \$50,000 shared between Dandridge, Jefferson Alliance, and County Commission.

Alderman Nelson – if it is not in the city limits, the town will not run sewer. We need commitment from the county to see if its even feasible.

Approval of Contract with Reducing Diesel Emissions for a Healthier Tennessee (\$57,000.00)

Town Administrator Shockley – Chief Riley was awarded a grant that would go towards offsetting the cost of the new engine by \$57,000. Contract states old engine that is being replaced has to be pulled out of operation and can't be sold to anyone else. The award is worth more than the value of the old engine.

Mayor Gantte/Vice-Mayor Kesterson- smaller fire departments in rural areas could use old engines. A lot of these places don't have the option to buy new engines. Other places have needs that this could fulfill to keep the citizens safe.

DWMF Tana Benson – They are similar size to us and they are experiencing very long lead times. Would prefer to sell to someone who needs it.
