*Bob Romines – White house right before you cross the bridge, steps haven't been used in probably 40 years. Wants to do a mural involving the high school art department. If it works well, we are looking at doing this every year..maybe do a scholarship or something each year. Can post a bond guaranteeing it for the next 10 years if need be. Asks board to be allowed to 1. paint concrete (will power wash and then paint with concrete primer) and 2. Allow kids to use colors that are outside of Historic color pallet.*
